

## GIFTS OF SECURITIES

If you sell appreciated assets you have held for more than one year, your gains are subject to a long-term capital gains tax; unless you donate them to a tax-exempt organization like the Central Point Parks & Recreation Foundation.

Consider a smarter strategy that offers not only immediate capital gains tax relief, but also a valuable, tax-saving deduction and possibly even increased income. A gift to Central Point Parks & Recreation Foundation of securities or real estate you have held long term (more than one year) is deductible at full present fair market value with no tax on the appreciation, allowing you to make a significant gift now, while you are living and able to witness the difference your donation makes.
